Redistricting, Election Integrity and Candidate Support



Party Actions in 2020

- Recruited and supported candidates in all state and federal races and most county races
- Built a clean contact database for 92% of the Republicans in PBC using third party sources as well as voter rolls
- Made over 1.3 Million voter contacts on behalf of candidates, GOTV efforts and to support the Republican "slate"
- Provided money, training, data and analysis, emails, robo calls, texting, GOTV mailers and and a poll watching team
- Created custom landing pages, routed callback numbers and other tools to directly interact with Republican voters



Key Factors in 2022

- Redistricting and the "candidate scramble"
- Proliferation of Vote by Mail (VBM) Ballots
- Election Integrity
- Get out the Vote (GOTV)



Redistricting


- Special Session approved Congressional Map
- Waiting on SOE to redefine precinct boundaries

Net changes:

- Congressional map very little
- Senate Map worse for Republicans
- House Map opportunities and risks
- County Commission gerrymandered CC2 and 3
- School Board minor tweaks


Congress

Net Effect of redistricting

- Party Bias similar to existing districts
- New CD21 (Mast) should stay Republican
- Other 3 are as hard as they always have been
 - Eg in 2020 Laura Loomer had a lot of Republican support in CD21 but only got 39% of the vote to Frankel's 59% (D+20)







New Districts Summary

What you can do:

- Find candidates that shares your values
- Donate, volunteer, promote in your neighborhood
- Look closely at the races that are potential flips or in which the candidate is at a disadvantage

Vote by Mail Ballots

VBM as % of the vote:

- November 2016 21%
- November 2020 49%
- March 2022 66%

VBM is here to stay



VBM Ballots

Pro: Flexible, vote early and check it was counted

Con: Easier to cheat, since ballots are outside SOE chain of custody

As long as it is here to stay – no point in not using the system – provides a hedge against missing election day voting



VBM Ballots in PBC

- Requires Identification to request and submit
- Drop boxes are controlled (SB90)
- Ballot status is available online
- Ballot "harvesting" outlawed

Safe and secure as long as we are watching



Election Integrity

Fact: the 2020 election results were suspect in many ways:

Zuckbucks, media control of narrative, social media censorship, unattended drop boxes in heavily DEM areas, weakening of voterID laws and the security of VBM ballots "because of the Covid emergency", suspect vote counting machines, etc. etc. etc.



Florida Response: SB90

- Prohibits zuckbucks (97.0291)
- Requires more ID when changing address, name, party, etc.
- Prohibits solicitation at drop boxes or at polling locations **
- Restrictions on duplication of ballots (in presence of canvassing board, observers)
- Limits duration of VBM subscriptions
- Prohibits sending VBM ballots without a request
- Limits on drop box locations **
- Allows close-in observers of canvassing board activities
- Prohibits ballot harvesting
- Puts limits on voter registration drives by third parties **

** Struck down by Judge Walker, pending appeal



Florida Response: HB524

- Election crimes and security unit inside SOS
- Clarifying prohibition on use of private funds
- Statewide voter registration application
- More frequent voter roll cleansing
- SOS to identify dead voters and input from DMV
- Prohibit ranked choice voting



Election Integrity Action Teams

- SB90 and HB524 are only tools enforcement requires public scrutiny of election operations
- Work in progress to form EI "Action Teams"
- REC, Pollworkers and pollwatchers, campaign volunteers
- Permanent structure
- Form relationship with SOE
- Access to all aspects of VBM process
- Include non-party grassroots in coalition

"Easy to Vote but Hard to Cheat"
